NOTE ON AGENCY GUIDANCE

While the listed guidance documents are not intended to impose new or additional legal requirements from those found in the underlying statute, or the implementing regulations developed through a formal rulemaking process, they are intended to inform the public about an agency's interpretation of, and enforcement priorities relating to, those statutes and regulations. There has been ongoing national dialog about whether the use of agency guidance documents in this manner alters the balance between complainant and respondent due process rights and imposes on educational institutions de facto additional statutory and regulatory requirements which haven't gone through a legislative or administrative rule-making process. While the Commission recognizes the current national debate over the desirability of informal agency action directing university action in the Title IX arena, the Commission viewed its responsibility as reviewing the UT Title IX program based on the existing state of statutory and regulatory requirements, including the relevant current guidance documents. It recognizes that either through future court decisions or actions of the DOE, it is possible that some of the guidance provided by DOE under prior administrations might be judicially restricted, or modified or withdrawn. The Commission makes no recommendation on UT's response in the event there is a judicial restriction or agency roll-back of existing DOE/OCR guidance, other than to note that any response should include UT's analysis of what would be considered Title IX best practices in light of the then remaining statutory and regulatory requirements, as well as student, parent, public, judicial, and community expectations based on what have become viewed as appropriate responses to sexual misconduct incidents.
